MRA RULE OF RACING 80

- (1) **In the event of a horse changing ownership after the date of registration of such horse, the new Owner shall within fourteen (14) days of the date of transfer, apply to the Secretary of the Association to register the change of ownership. A change in the composition of a partnership shall be deemed to be a change of ownership within the meaning of this Rule.**

- (2) **The application for change of ownership shall be accompanied by written confirmation from the previous Owner together with the registration fee. Provided always that this Rule shall not apply where, in the view of the Association, there are exceptional circumstances, including but not limited to where it is impossible for the new Owner to comply with the Rule.**
